Brief Description of the Programme

This course is designed to develop professional skills and techniques across a range of dance forms. We'll enhance students' previous dance and performance training by providing a broad understanding of the dance industry and the ability to manage a successful career in this exciting field. The course aims to encourage thinking practitioners of dance and spend time looking at performance development through dance science, considering performance optimisation techniques and current research. This dynamic top-up degree programme will also give students the opportunity to work with professional dance artists and choreographers in masterclasses and industry events.

This top up degree, is aimed at students who have completed a level 5 foundation degree/diploma but who now wish to progress their qualification into a full honour's degree. Whether this choice is made directly after gradation or following a professional career in the performance industry, this course offers them the chance to consolidate and develop their knowledge and understanding with a balance of practical and theoretical content. This course offers students the continuation of regular practical dance technique classes in jazz, ballet and conditioning whilst focusing on developing entrepreneurial and creative skills to help them create their own portfolio career in the dance industry. The programme also helps nurture their research skills to enable them to continue on to postgraduate study, a key factor if they wish to teach dance in schools/colleges or universities. The programme places a strong emphasis on self- and career-management and market placement and equips students with business and employability skills to support either an employed or self-employed career path. Ensuring longevity in the dance industry is also a key component so the course aims to nurture resilient dance graduates who have developed effective practical skills in looking after their own bodies, creating their own career opportunities and adapting effectively to new challenges.

Programme Aims

- 1 Prepare students for a career in the dance industry
- 2 Enhance students' performance skills and professional practice in a range of dance styles and contexts
- 3 Provide students with a conceptual understanding of the wider dance industry
- 4 Provide students with a working understanding of anatomy, physiology and psychology in relation to performance optimisation
- 5 Provide students with the necessary self-management skills to meet the demands of employment or self-employment

Programme Structure

Programmes are structured in stages. The number of stages will vary depending on the mode (e.g. full-time, part-time), duration and location of study which will be detailed in the Programme Handbook.

Modules are set at a specific academic level and listed as either core (compulsory) or optional. The level indicates the relative academic difficulty which will increase through the programme. Passing modules will reward you with academic credit. The amount of credits will depend on the complexity of the module and the level of effort required, which is measured in 'notional learning hours'.

Learning and Teaching Activities

Teaching and learning on the programme will help facilitate students' creative development, enabling them to integrate practice and theory with experiential learning as a key principle. A variety of teaching and learning methods will be employed during the programme and will include:

• Lectures and Seminars

Formal lectures will be used for the delivery of theoretical, sociological and historical aspects of dance, and for theoretical aspects of human physiology. Sessions may be formal class-based teaching or seminar workshops.

• Laboratory and Performance work

Students will have the opportunity to apply knowledge gained in the lectures into a practical setting through the use of specially designed activities during seminars and practical sessions in the Human Performance Laboratory or in the studio. Practical sessions have been designed to allow students to gain 'hands on' experience of using equipment, testing procedures and field-based assessments. Theoretical and practical use of research methods has been built into the modules allowing the student to analyse data when it is collected to enhance understanding and utilisation of statistical methods.

Masterclasses

Masterclasses will be scheduled throughout the year where dance professionals will be invited to deliver workshops. These will help expand students' knowledge of the variety of dance forms and equip them with additional skills.

Personal Tutorials

These are major teaching tools, which underpin the student learning experience particularly within their dissertation research project.

• Virtual Learning Environment

'Blackboard' is the University's choice of computer software for our virtual learning environment (VLE). It supports online teaching and learning and can be accessed by registered students and staff via the University's intranet system or by the internet from any location. Blackboard has become a key learning support tool whereby staff and student can communicate through text and image. Resources available within the 'environment' include, course information, module materials that can comprise of anything from lecture notes to video clips, discussion forums for communication between staff and students, administrative information such as calendars, and the setting and marking of online assessment. Blackboard will be used to support all modules on the programme.

Work-Based Learning

This is embedded coherently into the programme of study across all modules. The recording of the skills development is demanded by assessment from the outset. Through formative and summative assessment, students will be encouraged to develop areas of interest through their chosen projects. This will enable students to complete the course with a level of expertise and support them to apply for suitable employment upon graduation.

• Guided Independent Study

This is an important aspect of this level 6 course to help prepare students for future employment. Activities will include pre and post session readings, wider reading to inform critical understanding, completing a performance journal documenting learning and setting personal goals, personal practise time in the dance studios to work on technique and performance aspects of practice.

Additional Course Costs

There are costs associated with all studies, additional to the tuition fee, which require consideration, when planning and budgeting for expenditure. Costs are indicative and for the total length of the course shown unless otherwise stated and will increase with inflation; depending on the programme they may include equipment, printing, project materials, study trips, placement activities, DBS and/or other security checks.

- Books / Journals £50-£100 for any additional books or journal articles that may be needed for the research project.
- Printing
 Up to £50 per year for printing costs.
- Performances/Practical Classes Up to £100 for costumes/ dance wear/ dance shoes
- Graduation
 Graduation costs of £100 £200. This is an optional cost as attending graduation is not a requirement in order to have a degree conferred.

Contact Hours

1 unit of credit is the equivalent of 10 notional learning hours. Full time undergraduate students study 120 credits (1200 hours) and full-time postgraduate students study 180 credits (1800 hours) per year or 'stage' of the course.

The overall aim is to use innovative teaching and learning methods to guide students towards becoming more independent learners by the end of the programme, and to allow them to explore issues fully in the context of their work. Formative assessment creates a point from which

students and lecturers can appraise development, consolidate learning and plan ahead. Summative assessment allows recognition for progression to further study, informs those involved of the level of achievement, and validates the learning process.

Typical applicant profile and any programme-specific entry requirements

This top-up qualification is for students who have completed an HND, FdA or other equivalent qualification in a relevant dance-related subject and who wish to progress further to achieve an Honours degree. Applications are welcomed from dancers with any dance background, including both traditional and non-traditional forms, but the programme focuses primarily on jazz technique and is therefore aimed at those students with an interest in the commercial dance industry.

Applicants will be assessed through a recruitment process that includes a dance audition (on campus or via video submission if a campus visit is not possible), review of a piece of academic written work and an interview to assess their practical dance skills, academic writing skills and ability to benefit from the course. All students applying to the programme will be expected to demonstrate a specific interest in this area of study and should have a commitment to engaging with the subject.

Opportunities for students on successful completion of the programme

The programme places emphasis on self- and career-management and market placement and equips students with business and employability skills to support either an employed or self-employed career path. We would envision graduates to go into roles such as teachers, performers (if they have not already entered the course from this career route), entertainers, exercise instructors, managers, dance artists and onto further postgraduate study (PGCEs to enable dance teaching in schools/ Masters degrees for example).
