### **Brief Description of the Programme**

This programme relates to the **Professional** level. Bucks BSc (Hons) Accounting and Finance graduates are entitled to 9 (nine) ACCA exemptions at the Fundamentals level (F1 to F9).

The programme also aims to equip students with the ability to apply knowledge, skills and exercise professional judgement in the application and evaluation of financial reporting principles and practices in a range of business contexts and situations. The programme also covers two issues. The first is the external forces (the behaviour of customers, the initiatives of competitors, the emergence of new laws and regulations) that shape the environment of an organisation. The

second is the internal ambitions and concerns (desire for growth, the design of processes, the competences of employees, the financial resources) that exist within an organisation.

It also prepares senior financial executives or advisors, in taking or recommending decisions relating to the financial management of an organisation in private and public sectors. This may require managers to apply strategic management accounting techniques in different business contexts and to contribute to the evaluation of the performance of an organisation and its strategic development. Thus, able to advice individuals and businesses on the impact of the taxes on financial decisions. This may require relying on the assurance engagement and other audit and assurance issues in the context of best practice and current developments.

The main educational aims of the programme are to:

- 1 Build on the fundamentals that introduce learners to both financial and management accounting techniques
- 2 Cover the main technical areas that all accountants are expected to master.
- 3 Explore advanced skills and techniques you learners need to excel at professional level and
