# **Brief Description of the Programme**

This programme is designed to develop professional skills and techniques across a range of Acting forms focusing on Film, TV & Stage. We enhance students' previous acting training by providing a blend of critical analysis of dramatic texts and screenplays, alongside skills acquisition and development and performance, both for stage and screen.

The course aims to encourage critical thinking through a study of playwrights, performance skills and theatre and film practitioners. Tutors are research active and engage in research through practice, which informs all teaching with theoretical content.

This dynamic top-up degree programme will also give students the opportunity to engage with practitioners in the fields of theatre and film, to stage their own independently produced work and to study an area of interest they wish to research.

This top up degree, currently one of the only courses offered in this field in the South East, is aimed at students who have completed a level 5 foundation degree/diploma but who now wish to progress their qualification into a full honour's degree.

We support students to find a performance approach that's uniquely theirs, and set them up with the real-world skills required to put them in the best possible position to secure acting work when they graduate. Whether this choice is made directly after gradation or following a professional career in the performance industry, this course offers them the chance to consolidate and develop their knowledge and understanding through a balance of practical and theoretical content.

The course offers students the ability to stage an independent production, working in small groups to produce either a stage performance or short feature film, which can then tour. Practical work is supplemented by acquiring insight to the theatre and film industries, in modules informed by a mix of academic and industry practitioner lectures. The programme places a strong emphasis on self- and career-management and market placement and equips students with business and employability skills to support either an employed or self-employed career path.

Students also develop a critically informed approach to a specialist area of study, either by undertaking a practical dissertation that includes an element of performance on stage or on screen, or via a written dissertation.

# **Programme Aims**

- 1 Create mature artists with a comprehensive understanding of the UK Acting industry and the ability to apply performance practice to real-life settings.
- 2 Develop students' ability to select and synthesise approaches to acting in a manner that demonstrates a creative approach to the arts.
- 3 Encourage critical awareness and analysis of the political and ethical contexts of various examples of work in acting and performance.
- 4 Facilitate students' personal and professional development as actors and artists through work with professional practitioners.
- 5 Prepare students for employment by developing their technical and leadership skills.

### **Programme Structure**

Programmes are structured in stages. The number of stages will vary depending on the mode (e.g. full-time, part-time), duration and location of study which will be detailed in the Programme Handbook.

Modules are set at a specific academic level and listed as either core (compulsory) or optional. The level indicates the relative academic difficulty which will increase through the programme. Passing modules will reward you with academic credit. The amount of credits will depend on the complexity of the module and the level of effort required, which is measured in 'notional learning hours'.

# **Learning and Teaching Activities**

Please see the <u>Academic Advice pages</u> for a description of learning and teaching activities that are recognised by the University. Detailed information on this specific programme is outlined below:

Teaching and learning on the programme will help facilitate students' creative development, enabling them to integrate practice and theory with experiential learning as a key principle. A variety of teaching and learning methods will be employed during the programme and will include:

#### **Lectures and Seminars**

These develop analytical, critical and research skills. These generally take place in a classroom or lecture theatre, and combine tutor-led information-giving with student-centred discussions about the studied topics. They often include presentations and exercises.

#### Workshops

Students will have the opportunity to apply knowledge gained in the lectures into a practical setting through the use of specially designed activities during seminars and practical sessions in the studio. These develop practical and production skills. These are generally 3 hours long, taking place in the drama studio. They often involve physical work and deal with techniques practitioners need. Wearing comfortable, easy to move in clothes is advised.

#### **Performances**

These may be either public (i.e. to a paying audience), private (i.e. to an invited audience), or mediated (i.e. for camera). Their style and duration will vary according to the module, and they are feature across the degree. Students will have opportunities to work in many areas of production.

#### **Industry Panel and Visiting Lectures**

There is an annual Industry Panel with guests presenting experiences from the performing arts / acting industry. This affords students access to a professional network. Visiting lectures will be scheduled throughout the year where performing arts / acting professionals will be invited to deliver workshops. These will help expand students' knowledge of the variety of dance forms and equip them with additional skills.

# **Personal Tutorials**

These are major teaching tools, which underpin the student learning experience particularly within their dissertation research project.

#### **Virtual Learning Environment**

'Blackboard' is the University's choice of computer software for our virtual learning environment (VLE). It supports online teaching and learning and can be accessed by registered students and staff via the University's intranet system or by the internet from any location. Blackboard has become a key learning support tool whereby staff and student can communicate through text and image. Resources available within the 'environment' include, course information, module materials that can comprise of anything from lecture notes to video clips, discussion forums for communication between

staff and students, administrative information such as calendars, and the setting and marking of online assessment. Blackboard will be used to support all modules on the programme.

#### **Study Trips / Performances**

Sometimes these will be associated with assessment, but often they will not. These trips give you an opportunity to watch professional theatre and provide invaluable source material for lively classroom, Virtual Learning Environment and café/bar discussions

# **Guided Independent Study**

This is an important aspect of this level 6 course to help prepare students for future employment. Activities will include pre and post session readings, wider reading to inform critical understanding, completing a performance journal documenting learning and setting personal goals, personal practise time in the dance studios to work on technique and performance aspects of practice.

#### **Additional Course Costs**

There are costs associated with all studies, additional to the tuition fee, which require consideration, when planning and budgeting for expenditure. Costs are indicative and for the total length of the course shown unless otherwise stated and will increase with inflation; depending on the programme they may include equipment, printing, project materials, study trips, placement activities, DBS and/or other security checks.

#### Books / Journals

£50-£100 for any additional books or journal articles that may be needed for the research project.

# Printing

Up to £50 per year for printing costs.

#### Performances/Practical Classes

Up to £100 for costumes/performance wear / hard drive (useful for video storage)

#### Graduation

Graduation costs of £100 - £200. This is an optional cost as attending graduation is not a requirement in order to have a degree conferred.

#### **Contact Hours**

1 unit of credit is the equivalent of 10 notional learning hours. Full time undergraduate students study 120 credits (1200 hours) and full-time postgraduate students study 180 credits (1800 hours) per year or 'stage' of the course.

### **Assessment Methods**

The overall aim is to use innovative teaching and learning methods to guide students towards becoming more independent learners by the end of the programme, and to allow them to explore issues fully in the context of their work. Formative assessment creates a point from which students and lecturers can appraise development, consolidate learning and plan ahead. Summative assessment allows recognition for progression to further study, informs those involved of the level of achievement, and validates the learning process.

- All students who wish to enrol on the Top-Up programme will need to complete a Bridging Project, typically comprising a series of set tasks that will provide context, academic insights and basic skills activities to be completed prior to beginning the Top-Up programme at Buckinghamshire New University.

### Typical applicant profile and any programme-specific entry requirements

This top-up qualification is for students who have completed an HND, FdA or other equivalent qualification in a relevant performing arts / acting-related subject and who wish to progress further to achieve an Honours degree. Applications are welcomed from candidates with any performing arts / acting background, but the programme focuses primarily acting across a range of platforms including screen, stage and radio / podcast formats.

Applicants will be assessed through a recruitment process that includes an acting audition (on campus or via video submission if a campus visit is not possible), review of a piece of academic written work and an interview to assess their practical performing skills, academic writing skills and ability to benefit from the course. All students applying to the programme will be expected to

demonstrate a specific interest in this area of study and should have a commitment to engaging with the subject.

The programme places emphasis on self- and career-management and market placement and equips students with business and employability skills to support either an employed or self-employed career path.

We would envision graduates to go into roles such as teachers, performers (if they have not already entered the course from this career route), entertainers, exercise instructors, managers, performing artists, arts administration and onto further postgraduate study (PGCEs to enable dance teaching in schools/ Masters degrees for example).
