2. Programme Summary

The BSc (Hons) in Health and Social Science programme brings together the study of health with the study of wider society and its impact on health. Health and well-being are central to this degree programme and learners will examine national and international policies in these areas. Problems and issues facing socieities in relation to health and well-being will be examined throughout this programme with a strong focus on possible health policy solutions.

There is a focus on employability throughout this programme and learners will have the opportunity to volunteer for an organisation relevant to this degree which will help enhance learners' CVs for future graduate level employment. This is an innovative and varied degree programme which offers a coherent journey through health and well-being alongside social sciences.

The attribute of creativity will be developed through the consideration of key health problems and solutions to such problems (K2, T4, C2-3, P1-2) as well as within the design of learners' independent research projects (K4, C1). Leadership and self-development will be nurtured in this programme through the growth of skills of self-reflection, group work, communication skills and learning journey management skills (T1,3,5, P3-4, C3-4, K3).

The learning and teaching strategy for this programme is influenced by the desire to create a meaningful learning journey in which learners build confidence alongside knowledge and understanding of Health and Social Science. Active learning strategies are designed into individual modules with the use of workshop style learning across the curriculum. Assessment related tasks are built into workshops and seminars to create an authentic assessment experience for learners. Discussion based activities are in every module which supports our commitment to a meaningful learning journey where learners will apply their knowledge to explore solutions to health issues and problems. Study groups will be created in level 4 to facilitate cooperative learning whilst also helping learners to settle into BNU by working closely with the same few students on a regular basis. An Academic Skills programme will be a feature of Level 4 where learners will develop the necessary skills to facilitate their academic journey. Cooperative learning, inclusion and respect are key to the learning and teaching strategy in this programme.
