## 2. Programme Summary

This programme is aimed at learners who wish to acquire knowledge of the law, develop high-level transferable and applied skill-sets in legal practice, advocacy, research, and enhance their employability whether for careers in law or other graduate careers. The LLB is a three-year full-time bachelor degree programme designed with an innovative, international and contemporary perspective. It is designed to focus on contemporary issues in law with an

innovative teaching approach that underscores employability and professional skills and practice. It is also designed to meet the requirements of the SRA and BSB for recognition as a Qualifying Law Degree for the purposes of completion of those bodies' academic stage of training. If you wish to focus on the law in relation to business and commerce, the LLB Business Law programme provides the opportunity to study a range of areas relevant to the governance and regulation of business entities.

The degree will provide you with a strong foundation of legal knowledge and an understanding of the broader social, economic and political contexts within which the law operates. The programme consists of a blend of professional and academic elements which particularly focuses on transferable and applied skills to provide you a broad learning base for advancing your career before and after graduation. You will be tutored in a contemporary and globalised curriculum to enhance your competitiveness, employability and skills base. If you intend to become a solicitor or barrister, the award, as a Qualifying Law Degree exempts you from the requirement to undertake a Graduate Diploma in Law before commencing the Legal Practice Course or the Bar Professional Training Course (the Vocational Stage of Education), Opportunities available for you after completion of the award: You will gain the knowledge and skills to undertake the Vocational Stage of Education for later qualification as a solicitor or barrister, or to undertake post-graduate academic legal study. Law graduates, with high level of competency in communication and analysis (as well as knowledge of the law) are attractive to a range of graduate employers, including those offering careers in legal practice; law enforcement; regulatory and compliance; policy making; the justice system; and a wide-range of careers.

Learners are developed to be highly employable by fostering the attributes of social and ethical awareness and responsibility through ensuring an understanding of the complexities of legal concepts, rules and principles and an understanding of the values of justice and rule of law to the foundations of society (K1-4, C2-4, P2-3). These approaches further enhance the attributes of leadership and self-development through equipping learners with skills and abilities that are transferable to various disciplines and careers such as criminal justice, education, public policy, in the UK and Internationally ( P3-5, T3-4).

## 4. Entry Requirements

The University's <u>general entry requirements</u> will apply to admission to this programme with the following additions / exceptions:

- 3 A Levels at grades ranging from AAB-BBB or equivalent, a UCAS Tariff score of 260 and a typical entrant would be expected to have GCSE English and Mathematics at Level 4 or above.
- Applicants should have basic IT skills, but no previous knowledge or qualification relating to law is required. If your first language is not English, you will be expected to have an overall IELTS band score of 6.0 (with 5.5 in each element of Listening, Reading, Writing and Speaking)

If you do not meet the entry requirements you may, if you have relevant professional experience, still be invited for interview, where you will be required to demonstrate the necessary knowledge and understanding for entry onto the course.

Previous study, professional and / or vocational experiences may be recognised as the equivalent learning experience and permit exemption from studying certain modules in accordance with our <u>accreditation of prior learning</u> (APL) process.

#### 6. Learning, Teaching and Assessment

#### Learning and teaching

Throughout the award the object is to develop the legal knowledge, academic and professional, legal, skills and analytical ability of learners to enable them to enter successful careers in law and other graduate careers. This will be achieved through a combination of lectures, seminars, interactive workshops and practical activities, as well as self-guided study and directed research. Learners will have the opportunity to work both individually and in teams.

At foundation level, learners will be given the opportunity to engage in a variety of summative and formative assessments, both law related, and skills based, and at the same time, develop the academic skills necessary to become a successful student at university and capable of independent learning. The course content and the learning outcomes relate directly to learners developing their legal knowledge and understanding of the subjects being studied and assessed.

At levels 4, 5, 6 a variety of learning and teaching methods will be utilised, including classroom-based activities such as lectures, seminars, interactive workshops together with independent learning methods and practical activities. The classroom sessions are all learner-focused and interactive, adaptable to both small and larger groups of learners. The lectures will provide a structure to the topic area in order to facilitate understanding and encourage learners to develop their critical thinking skills in relation to the subject matter as they progress through the different stages of their law degree programme.

At level 4 learners will interact at a more introductory level, building the basis of their legal knowledge, academic and professional skills. At this level seminars and workshops will also provide learners with opportunities to interact and collaborate with each other and the tutor and begin to engage with the subject matter, identify legal issues and engage in discussion/formulate legal arguments.

By level 5, learners are encouraged to acquire more in-depth legal knowledge and understanding of the subjects, engage in greater analysis and discussion, building upon the foundational legal structures and skills they encountered in level 4.

At level 6, learners will be encouraged to demonstrate their ability as competent independent learners as well as critical analytical skills, evaluation, and application of their legal knowledge and skills, and understanding of process, to the level expected of a graduate entrant.

In addition to course level learning and teaching, learners will also have access to a range of University-wide learning and teaching resources offered by a variety of University departments, as well as the University's **Virtual Learning Environment** – this digitally-based programme offers a wide range of features which support the subject level teaching as a support resource. This will include electronic access to general and subject course documents, subject module guides and reading lists, lecture handouts, seminar and workshop activities, assessment guidelines, library/learning resources links to E journals as well as providing resources pages and on-line links to legal articles and other academic and professional materials of relevance to the module. Learners will also be able to use the discussion board facility for peer support and to receive notices to maintain communication between lecturer and learners and with each other/learner groups.

#### Assessment

Learners will be assessment by means of both formative and summative assessments. Summative assessments will test the achievement of the module learning outcomes. Formative assessments, whilst not providing marks toward a final grade will provide learners with the opportunity to continue building up their legal knowledge and skills with feedback from both tutors, and peers, in order to enhance and improve their performance in summative assessments.

A range of summative assessment methods are incorporated across the substantive law and skills subject modules on this course. These will include written essay/report-style and problem-solving/client advice assessments, where learners will be able to show in-depth understanding of a particular aspect/issue of law. Written assessments will also engage learner in conducting a systematic literature review and provide the opportunity for learners to demonstrate critical analysis, synthesis and evaluation of the legal principles, processes and debates in relation to a particular topic area and to be able to present a clear and reasoned legal-based argument. Oral presentations will permit learners to demonstrate their legal knowledge and legal academic/professional skills, by means of effective verbal communication skills in a variety of legal contexts, including client advice/advocacy.

The **final dissertation** will represent a major piece of structured independent research, focused on the legal topic/issues chosen by the learner in their final year, level 6. This will be undertaken by the learner independently, with the support from an academic supervisor who will be available to meet with the learner regularly throughout the course.

#### Contact Hours

Learners will engage with 12 hours of scheduled learning activities per week. This will comprise a combination of lectures, seminars and workshops. A full breakdown of contact hours can be found in individual module descriptors.
